I, Atul Kumar Labh, Practicing Company Secretary (FCS – 4848 / CP - 3238) and proprietor of M/s. A. K. - 1. The remote e-voting period remained open from 9.00 A.M. IST on Friday, the 18th day of December, 2020 up to 5.00 P.M. IST on Sunday, the 20th day of December, 2020.
- The shareholders holding shares as on the "cut off" date, i.e. the 14th day of December, 2020 were entitled to vote on the proposed 3 (Three) resolutions as mentioned in the Notice dated the 11th day of November, 2020 of the AGM of the Company.
- 3. The Company has also provided e-voting facility at the AGM to enable the shareholders attending the AGM through VC / OAVM to cast the votes in case the same has not been cast by them through remote e-voting.
