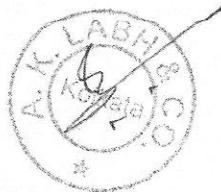

I submit my report as under:

1. The remote e-voting period remained open from 09:00 A.M. IST on Friday, the 27<sup>th</sup> day of September, 2024 up to 5:00 P.M. IST on Sunday, the 29<sup>th</sup> day of September, 2024.
2. The shareholders holding shares as on the "cut off" date, i.e. the 23<sup>rd</sup> day of September, 2024 were entitled to vote on the proposed 4 (Four) resolutions as mentioned in the Notice of the AGM dated the 12<sup>th</sup> day of August, 2024.

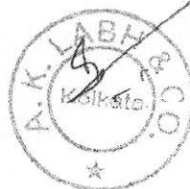
